Sealed bids will be received by the **Bishop International Airport Authority**, at the Administration Office until the time specified above, at which time and place all bids will be publicly opened and read aloud. **ANY BID RECEIVED AFTER THE SPECIFIED TIME WILL NOT BE CONSIDERED.**

**The proposed Work includes the following:**

- Construction of a new 35' wide taxilane (earthwork, drainage improvements, electrical modifications, paving of approx. 1,000 tons of asphalt, restoration)
- Construction of a 24' wide, two-lane new perimeter road connecting from the deicing apron, around the eastern side of the airfield, to the AirPark taxilane (earthwork, drainage improvements, paving of approx. 4,100 tons of asphalt, restoration)

**Bidder Qualifications**

**Prime Bidder must be prequalified with MDOT. This project includes designated item classifications Cb (Hot Mix Asphalt/Bituminous Paving), Ea (Grading, Drainage Structures & Agg. Cons), and L (Electrical Construction). If the prime bidder is not prequalified in these item classifications, then it must use prequalified subcontractors. The subcontractors must be designated prior to award of the contract to the confirmed low bidder.**

**There is a Disadvantage Business Enterprise (DBE) participation goal of 0.00% for this project.**
